

2017 Upper Keys Fishing Club (UKFC)

Summer Dolphin (Mahi Mahi) Rodeo June 17, 2017

1. This is a one day boat tournament open to all Upper Keys Fishing Club (UKFC) members in good standing.

This is a MEMBERS only fishing tournament, if you are not a member you cannot fish the tournament. Only club members can be on a boat that is in the contest.

The number of licensed anglers on the boat is limited only by what the vessel can safely carry. There is a \$25 Registration fee per boat and Pre-registration is required at least 72 hours before the tournament starts. Entries will be accepted by any tournament committee member or club officer.

2. Fish cannot be caught on a charter boat unless that boat is owned by a member.

3. Tournament times: June 17 – 7:00 AM until 3:30 p.m. -- Weigh in 4:30 – 5:30 p.m. The weigh in will be at the Chickee at Taylor Creek Village mm 104.5 ocean side in front of 219 lance lane Juan Andres's house Only bring fish to be weighed to the weigh in. No fish will be weighed in after 5:30 p.m.

The tournament is for Dolphin (Mahi Mahi). There will be two divisions a Men's and a Women's, each will have a first place winner largest fish and a total weight of three fish. Each member may enter one fish for the largest fish and three additional fish for the total weight. If a fish is weighted towards the largest fish category it cannot be used in the three fish category (the winner will be chosen by actual weight). The All fish weight must meet minimum Florida size requirements

4. The catching of bait (including use of hook and line) will be allowed prior to tournament start. Fish will be weighed on a first come first serve basis. Boats must leave from a port located between Ocean Reef and Long Key.

5. In order to qualify, a fish must be caught by rod and reel in accordance with all Florida fishing regulations.

6. Rules committee (3 participating captains) will make any decisions necessary with regard to rule compliance. In the event a committee member is involved the tournament chairman will vote in their place. The Tournament channel is 72.

7. The tournament does not provide a weather committee and it is a captain's choice tournament. All team captains, members, boat owners, and all other participants are responsible to determine that their craft is sea-worthy and are advised and encouraged to be familiar with the current local weather conditions and forecasts to determine if the conditions permit the safety of the boat, crew, anglers, and guests to proceed to departure to sea and return in a safe and prudent manner. The UKFC reserves the right to postpone the tournament. To make it safer and more defined as to when it will be held and when it will be cancelled. The decision to cancel the Rodeo will be made by the NOAA forecast for waves and if it calls for waves over 4ft on the 4:30 forecast the previous day, it will be cancelled.

HOLD HARMLESS Acknowledgement of Risks:

RELEASE: I hereby voluntarily release the UKFC, its agents, or board of directors and all other persons or entities from any and all liability, claims, demands, actions or rights of action, which are related to, or are in any way connected with my participation in this activity, including specifically, but not limited to the negligent acts, or omissions of the UKFC, its agents and all other entities for any and all injury, death, damage to myself, or to my property. I further agree, promise and covenant to hold harmless and indemnify the UKFC, its agents, or board of directors, and all other persons or entities from all defense costs, including attorney's fees, or from any other costs incurred in connection with claims for bodily injury, or property damage which I may negligently, or intentionally cause to other third parties in the course of my participation in this activity. I further agree, promise and covenant not to sue, assert, or otherwise maintain, or assert any claim against the UKFC, its agents, board of directors and all other persons or entities, for any injury, death, or damage to myself, or my property, arising from, or in connection with my participation in the activity, or from any claim asserted against me by other third parties. In signing this document, I fully recognize that if anyone is hurt, or property is damaged while I am engaged in this activity, I will have no right to make a claim, or file a lawsuit against the UKFC or its officers, agents, or board of directors, even if any of them negligently cause bodily injury or damage.

EFFECT OF THIS RELEASE AGREEMENT: I understand and acknowledge that by initiating and/or signing this document, I have given up certain legal rights and/or possible claims which I might otherwise assert, or maintain against the UKFC, its agents, or Board of directors and other persons, or entities, including specifically, but not limited to, rights arising from, or claims for the acts, or omissions, negligent in any degree, of the UKFC its agents, board of directors and all other persons, or entities.

I understand and acknowledge that by initiating and/or signing this document, I have assumed responsibility and legal liability for the claims, or other legal actions, including defense costs, which may be asserted by crew members, or third parties against me as a result of participation in this activity.

I understand that this entire agreement between myself and the UKFC its agents, or board of directors and that it cannot be modified, or changed in any way by the representative, or statements of any board member, or agent of the UKFC or by me.

My signature below indicates that I have read this entire document, understand it completely and agree to be bound by its terms.
